Academy District 20 residents have the opportunity to have their children, ages 3-5, attend preschool in one of our district preschools.

**To Apply for D20 Preschool you must be a D20 resident.**

*Our mission at Academy District 20 Preschool is to partner with families and the community to educate children of all abilities in a safe and nurturing environment by providing developmentally appropriate instruction that creates a foundation for future academic success, social-emotional well-being, and exemplary citizenship.*

- Highly qualified, licensed early childhood/special educators
- 1:5 teacher/student ratio
- Integrated classes meeting all children's needs
- Provide opportunities to explore, extend and experiment
- Teacher guided experiences
- Activities representing language, motor, cognitive and social emotional development
- Age appropriate activities which facilitate individual learning styles
- Big books, read aloud, circle time, art, and outdoor play
- Centers including blocks, science centers and dramatic play

**Preschool locations include:** Antelope Trails Elementary, Briargate Preschool, Discovery Canyon Campus Elementary, Edith Wolford Elementary, Explorer Elementary, Frontier Elementary, High Plains Elementary, Legacy Peak Elementary, Ranch Creek Elementary, The da Vinci Academy and Woodmen-Roberts Elementary. ***Three year old children are placed in the morning (AM) classes, and 4 year old children are placed in the afternoon (PM) classes.***

### **Application Process**

- Return the attached application indicating your choice of school and class with the **\$55.00 non-refundable application fee** (payable to Academy School District 20).
- Children will be selected by a lottery when application is received between Jan. 24, 2020 and Feb. 28, 2020. Applications received after this date will be put on a waitlist.
- **Do not** complete the online registration process until you have been notified by letter of your child's preschool placement.

### **Requirements**

- **All typical peers must be independent with toileting skills.**
- Children must be 3 years of age by October 1, 2020 and be 3 years of age before starting preschool.
- Children who have turned 5 years of age by October 1, 2020 will no longer meet the age requirements for preschool, but qualify for kindergarten.

### **Tuition**

- Tuition fee is \$260.00 per month, for four half days per week. Each session is 3 hours (Mon, Tue, Thur, Fri).
- Payments are due on the 1<sup>st</sup> day of each month. (**No invoices are sent out.**)
- Billing begins in September and runs through May. Additional school fees will be determined by each location and are the responsibility of each family.
- Fees are contingent upon Board of Education approval as part of the district wide fee schedule and could change.

### **Colorado Preschool Program (CPP)**

Academy School District 20 has a grant through the Colorado Preschool Program which allows D20 to provide preschool at no cost for a limited number of children who meet CPP criteria. (Some school fees may apply.) Children must be considered at risk for school success to qualify for CPP. Preschool days are 4 half-day sessions 3 hours a day, Monday, Tuesday, Thursday, Friday. The monthly tuition is \$260.00, due by the 1st of each month. Fees are contingent upon Board of Education approval as part of the district wide fee schedule and could change. Payments begin on September 1.
