<u>Semester ride passes</u> may be purchased with a credit/debit card using the Infinite Campus parent portal, or by cash or check at the transportation center or Education and Administration Center. 20Ride passes must be purchased prior to riding a bus. Semester passes are nonrefundable, either in part or in whole.
